

AGREEMENT

This DEED of AGREEMENT is made and executed on 01st day of August 2020

BETWEEN

M/s Sangam Laxmibai Vidyapeet (Registration No (24) of 1955 – 45 Dt: 31.08.1955 and registered under the Society Registration Act), comprising institutions viz, 1. M H Gupta High School for Girls. 2. Sangam Laxmibai Junior College for Girls. 3. KV Ranga Reddy Degree College for Women. 4. Bojjam Narsimhulu Pharmacy College for Women. 5. Bhoj Reddy Engineering College for Women represented by Mrs. E Vijaya Lakshmi HEREIN AFTER referred to as **Party of the FIRST PART (Which expression shall include and mean all Executives, Nominees and the Administrators of SLV) – the one Part.**

AND

Now, therefore, this agreement witnesses as follows:

1. That this agreement is valid for a period of three years, i.e. from 01.08.2020 to 31.07.2023 subject to the satisfactory Services of the Party of Second Part and as per the Terms & Conditions laid down in this Agreement.
2. That the **PARTY of SECOND PART** shall provide web-based interface for the SLV Institutions to make all the workplace exercises into online platform and shall design, develop and implement applications software according to the functional specifications and related information.
3. The Second Party will request help of employees of First Party for designing and implementing the software to be developed hereunder.
4. **The FIRST PARTY** shall pay the amount to the **Party of Second Part** in monthly bill raised by the Second Party.
5. That the **PARTY of the SECOND PART** shall submit his TDS Number (Tan/Pan number) to the **PARTY of the FIRST PART** within one month from the date of effect of this agreement.
6. That the **Party of SECOND PART** shall receive the **BILL AMOUNT** from the **PARTY of the FIRST PART** only after making deductions towards **TDS** as per the **IT Rules**, which are variable from time to time.
7. That, Though the payment is based upon certification, the **PARTY of the FIRST PART** reserves the right to withhold any amount/s from the Raised Bill of the **PARTY of SECOND PART**.
8. That the **PARTY of the SECOND PART** shall have to visit all the SLV Institutions every week for required data collection and presenting work progress.
9. That, though this **SLV Online Portal Development** agreement expired three years from the date of commencement, subject to the satisfactory service, this contract may be withdrawn by the either side of the Parties giving One Month Notice.
10. That, Both the **PARTIES** representing **FIRST and SECOND PART** agreed upon to abide by the conditions laid down in this agreement.
